At the last Centre conference in Oxford there were participants from 20 different countries present. We had a running contract with SCM press to publish the proceedings of our conferences and three volumes were published. Since then the proceedings have appeared in other forms, and we have a strong relationship with Wipf and Stock. I am now the President of the Centre.

The CoTP is a co-sponsor of the annual Summer School of the Edith Stein Institute of Philosophy, Granada.

It also publishes an online academic journal; RO:TPP: Radical Orthodoxy: Theology, Philosophy, Politics.

In October 2010 I became a co-founder of Nottingham Citizens.

From 2010 to 2017 I was the Chairman of the thinktank *Respublica*, directed by my former pupil Phillip Blond.

From 2019 onwards I became the President of the *Methexis Institute* in Charlottesville Virginia, a sister institution of the CoTP.

From the Spring of 2020 I became a founder member of *Ordo Amoris*, an organisation dedicated to the building of a new poosstliberal geopolitical order around friendship rather than liberal contracting.
